What is it like to attend George's early years setting?

This childminder early educator provides good-quality care and education.

Children are happy and secure in this in George's home setting. The learning environment is stimulating and encourages children to develop their curiosity. They have access to a wide range of toys and activities, with construction play being a popular choice. This type of activity helps to develop children's physical skills.

The focus activity was linked to this term's topic, 'Winter.' Previously, the children participated in winter walks within the local community and visited the post box to send letters they had written to Santa. These real-life learning experiences help children develop their understanding of the world around them.

In this session, the children explored their 'Winter' topic further by learning about Arctic animals. They were able to recognise a polar bear and discuss its habitat. The children put on winter hats, scarves, and gloves and embarked on a 'bear hunt'. They then worked together as a team to construct an igloo, an activity that fostered problem-solving and teamwork skills. Throughout, they demonstrated resilience and determination, celebrating their success when the igloo was completed.

What does George do well?

- George has developed rigorous risk assessments for the setting, using the early years app, BabyDays, to regularly review and update them.
- He has established a thorough induction process for his assistants, ensuring they receive comprehensive training, particularly in safeguarding.
- As the designated safeguarding lead, George attends additional safeguarding training and prioritises the protections of children.
- George manages administrative tasks efficiently, ensuring that all policies and procedures are in place, regularly reviewed, and updated.
- He knows the children well and can confidently discuss their individual interests, preferences, and learning styles.
- George plans engaging activities to extend children's learning. For example, they visit local shops and use the ingredients they buy to prepare meals together.
- Communication with parents is facilitated via BabyDays, where assessments and observations are regularly shared.
- George is enhancing the play space to provide pre-school children with a more focused learning environment, supporting their transition to school.
- The setting promotes emotional literacy, with a calming corner where children can read books and reflect on their feelings.
- Physical activity is highly valued, with daily yoga sessions that positively impact children's physical development.

What does the setting need to do to improve?

- Continue developing children's next steps in each area of learning.
- Further refine his self-reflective documents (the Self-Evaluation Quality Improvement Plan).

Safeguarding

The arrangements for safeguarding are effective.

George has a robust understanding of the signs and symptoms of potential harm and knows the correct referral procedures. He demonstrates secure knowledge of broader safeguarding issues. The home and garden, where children play, are safe and secure, with regular risk assessments ensuring ongoing safety. Additionally, George conducts risk assessments for outings to minimise potential hazards, ensuring children's welfare remains a priority.

The educator was registered in 2016. George was registered in November 2023 and holds a Level 3 qualification. His setting operates from 6:30 am to 9:00 pm, five days a week, year-round. He provides funded early education for 2-, 3-, and 4-year-old children

George had a quality assurance visit within the past year, which is not conducted as an inspection, therefore a quality judgement was not given. The educator received verbal and written feedback, as usual.

As part of the visit, the inspector completed a range of activities including:

- Observing the quality of teaching during activities and assessing the impact this has on children's learning. Including conducting a joint evaluation with the educator of a planned adult led activity.
- Discussing the educator's and assistants' practice at appropriate times throughout the visit
- Reviewing the children's assessment records, observations and planning on the agency's EYFS learning journal software
- Viewing the areas of the house used for early education and reviewing a selection of policies
- Collecting the views of parents from surveys, the educator's own questionnaires and any spoken to on the day
- Discussing the educator's self-evaluation and plans for improvement

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the Early Years Foundation Stage. If you are not happy with the inspection or the report, you can complain to Ofsted.

The Quality Appraisal Inspection visit was conducted by a Support, Advice and Mentor (SAM) from @Home Childcare Childminder Agency in line with A guide for Childminder Agencies⁽¹⁾. The visiting inspector reviewed all aspects of the childminder's setting to ensure they were meeting the requirements of the Early Years Foundation Stage Statutory Framework⁽²⁾.
